1. Overview of the 2022 Offering

This scholarship is open to foreign students studying at a Japanese university in their sophomore or junior year. The Frances & Sachio Semmoto Foundation aims to provide financial assistance to talented students of demonstrated financial need from Asia–Pacific nations who wish to pursue postsecondary education in Japan. We aim to provide the means by which such students may grow to become the future leaders of their nations, thereby fostering mutual understanding and friendship between Japan and our Asia–Pacific neighbors. **In FY2022, we intend to give priority to those whose entry into Japan was delayed by the COVID-19 pandemic.**

2. Eligibility Criteria

(1) Nationalities and Visas

Open to students of the following nationalities studying at Japanese universities who hold a student visa

Cambodia	Indonesia	Laos
Malaysia	Myanmar	Philippines
Thailand	United States	Vietnam

(2) Level of Study

Open to sophomores and juniors as of October 1, 2022 enrolled in a four-year undergraduate program at the following designated universities.

【Designated Universities】

Aoyama Gakuin University, Chuo University, Doshisha University, Hitotsubashi University, Hokkaido University, Hosei University, International Christian University, Kansai University, Kansei Gakuin University, Keio University, Kobe University, Kyoto University, Kyushu University, Meiji University, Nagoya University, Osaka University, Rikkyo University, Ritsumeikan University, Sophia University, Tohoku University, Tokyo Institute of Technology, Tokyo University of Science, University of Tokyo, University of Tsukuba, Waseda University

(3) Academics/Health

In addition to academic excellence, applicants must have a demonstrated interest in cross-cultural understanding and communication skills, a sincere attitude toward their goals, and be physically and mentally sound enough to endure life as a foreign exchange student.

(4) Economic Conditions

The scholarship serves those who would have difficulty paying the full amount of study abroad expenses due to financial reasons.

(5) Age

Applicants must have been born on or after April 1, 1993 (under 29 years of age as of March 31, 2022).

No more than 7

4. Scholarship Overview

(1) Amount of Scholarship

¥ 80,000 per month

(2) Period of Scholarship

October 2022 – September 2023 (1 year)

(3) Scholarship Payment Methods

In principle, one month's payment will be transferred to the scholar's account on the 10th of each month. (Only the first payment for October will be transferred together with the payment for November, for a total of two months' payment in November.) If the 10th falls on a holiday (Saturday, Sunday, or a national holiday), the payment will be made on the weekday immediately preceding the holiday.

(4) Scholars' Obligations

- ① Participation in Foundation events (once or twice per year)
- ② Submission of scholarship receipts (monthly)
- ③ Submission of scholarship reports (once every two months)
- ④ Cooperation with publicity activities (publication of name, school name, photo, and scholarship report)
- ⑤ Submission of academic transcripts (once every six months)
- ⑥ Attend individual interviews (once per year, online)
- ⑦ Submission of necessary notifications
Scholars are required to report and submit to the Foundation notice of any of the following events:
 - Notification of a change in status
 - In the event of a leave of absence from school, suspension, transfer, or withdrawal from school
 - When a scholar rejects the scholarship
 - When a scholar moves to a new residence, changes his/her name, or undergoes any other change in his/her personal circumstances
 - When there is a change in the scholar's head of household (dependent) or emergency contact person (death, change of address, name change, etc.)
 - When the scholar's visa status is no longer that of "student"
 - Notification of part-time work
 - When a part-time job is newly started/changed/interrupted
 - Notification of departure
 - When leaving Japan temporarily
 - When there is a change in other important matters
- ⑧ Compliance with the laws of Japan and the regulations of your school

5. Application and Screening Schedule

When applying for a SEMMOTO scholarship, **you MUST submit both (1) your application by post and (2) your assigned essay online.** **Please be sure to complete both the posting and online submission procedures,** as we cannot accept only one of them.

② Document Screening

③ Notification of Results of Document Screening

Applications will be reviewed, and up to nine applicants will be selected for the document screening. Applicants will be notified directly of the screening results by Wednesday, September 9, 2022. Applicants who pass the document screening will be sent information on the time and venue of the interview examination, along with a notification of acceptance.

④ Interview Examination

Interviews in groups of three will be held on Sunday, October 2, 2022 from 13:00 to 16:00 for 30 to 40 minutes. The interviews will be conducted in the language in which the application documents were prepared (Japanese or English).

Transportation expenses will be paid for those who live more than 100 km away from the Foundation's headquarters (Kyobashi Edogran 18F, 2-2-1 Kyobashi, Chuo-ku, Tokyo). Details will be provided only to those who have passed the document screening and are eligible.

⑤ Notification of Results of Interview Examination

Applicants will be notified directly of the results of the interview examination by Monday, October 21, 2022. Successful applicants will have until Tuesday, November 1, 2022 to reply and indicate whether they wish to receive this scholarship and to register their contact information.

⑥ Scholarship Payments Begin in November 2022.

■ Purpose of Establishment

The Frances & Sachio Semmoto Foundation aims to provide financial assistance to talented students of demonstrated financial need from Asia–Pacific nations who want to pursue postsecondary education in Japan. We aim to provide the means by which such students may grow to become the future leaders of their nations, thereby fostering mutual understanding and friendship between Japan and our Asia–Pacific neighbors.

During the 1960s, when overseas higher education remained out of reach for the vast majority of Japanese students, I was fortunate enough to study abroad in the United States as a part of the Fulbright Scholar Program. Through this experience, I encountered a globally minded ethos of social consciousness that was deeply rooted in liberal American values. My formative experiences during this time strongly informed my own values and philosophy and contributed significantly to my decision to found the DDI Corporation (now the KDDI Corporation, one of the leading Japanese telecom companies) and several other companies.

I strongly believe that Japan, a nation that has benefitted enormously from the world’s goodwill during its postwar reconstruction, and more recently, following the 2011 Tohoku Earthquake and Tsunami, has a responsibility to give back to the global community. It is with this purpose that we founded the Frances & Sachio Semmoto Foundation to provide students from Asia–Pacific nations who otherwise would not have the means to fulfill their educational goals access to postsecondary education in Japan.

It is my hope and desire that these students will have formative experiences much like those I had during my studies as a Fulbright scholar, and that they will grow to become global leaders with strong ties to, and a deep understanding of, Japan.
